Corrections will be made only for errors which I communicate to Service Provider within 90 calendar days of the end of the last calendar quarter. Thereafter, account information shall be deemed accurate and acceptable to me. If I notify Service Provider of an error after this 90 days, the correction will be only processed from the date of notification forward and not on a retroactive basis.
